## OTHER UPDATES AND M&A DEALS

- Naario, Rupifi, Netmonastery, Uravu Labs, WayCool, Learning Matters, KalaGato, Kreate and HealthySure did not disclose their financial details.
- Edtech giant upGrad has entered into an exclusive agreement to acquire online higher education company Talentedge
- Byju's on Wednesday said it has bought Austria-headquartered math learning platform GeoGebra, making it the Indian edtech giant's tenth acquisition this year
- Electric two-wheeler mobility platform eBikeGo has acquired the rights to manufacture 'Muvi' electric vehicles (EVs) of Spanish automotive company Torrot in India.
- Brightcom Group Ltd, an ad-tech company, has acquired Vuchi Media Pvt Ltd, which operates MediaMint, a digital consulting and operations services firm for Rs 566 crore (around \$75 million).
- Thrasio-style house of brands player, Mensa Brands, has acquired Mumbai-based home décor and kitchenware brand Folkulture for an undisclosed amount in its 13th acquisition this year.
